

Section 2 - Hazards Identification

Emergency Overview: A(n) white to off-white paste product with a slight odor. WARNING! May cause eye, skin, nose, throat and respiratory tract irritation. May cause sensitization by inhalation and skin contact. Harmful if swallowed or absorbed through the skin. Remove contact lenses before using.

Effects Of Overexposure - Eye Contact: May cause eye irritation, characterized by a burning sensation, redness, tearing, and inflammation. Signs and symptoms may include: pain, tears, swelling, redness and blurred vision.

Effects Of Overexposure - Skin Contact: Causes Moderate skin irritation. Harmful if absorbed through the skin. Prolonged or repeated skin contact can result in sensitization and dermatitis.

Effects Of Overexposure - Inhalation: May be harmful if inhaled. During application and cure, this product releases methanol, which may affect the brain or nervous system causing dizziness, headache or nausea. May cause blurred vision. Section 7 - Handling And Storage

Handling: KEEP OUT OF REACH OF CHILDREN! DO NOT TAKE INTERNALLY. Open all windows and doors or use other means to ensure cross-ventilation and fresh air entry during application and drying. Odor is not an adequate warning for hazardous conditions. Use only with adequate ventilation. Avoid breathing vapor and contact with eyes, skin and clothing. Wash thoroughly after handling.
